

RULES & REGULATIONS FOR TIMES SHE UNLTD. ENTREPRENEUR AWARDS 2019
ONLINE VOTING

All online activities (“Activity (ies)”) pertaining to the award “TIMES SHE UNLTD. ENTREPRENEUR AWARDS 2019” will be hosted on the www.timesheunltd.com which is open to all users who wish to participate subject to abiding the below terms and conditions.

1. **Eligibility:** Indian residents who are above 18 years of age are eligible for the purpose of participating in the Voting Activities (“Activities”). Employees of Bennett Coleman & Co. Ltd. (“Company” & / or “BCCL”) and its affiliates, subsidiaries, assignees, Process evaluators and Process Auditors, representatives and the immediate families of the Company and as well as the subsidiaries that are sponsoring and/or promoting the show are not eligible or allowed for participating in the Voting Activities

2. **General Terms & Conditions:**
 - a. The voting period remain open from April 02, 2019 (18:00 hrs) to May 05, 2019 (12:00 midnight)
 - b. Each Voter will get 5 nos. of votes per day which can be exercised for voting participants / contestants
 - c. The name of the contestant/ participants will be added to the participant list as an when the participants meets the eligibility criteria and this process will continue till April 20, 2019
 - d. Total vote of the participants will be determined on the basis of the number of votes obtained during the tenure of the voting period.
 - e. Voting Activities which are supposed to be completed within the duration of the voting period, shall only be considered if the entries are received within such timelines. The server time of BCCL shall be considered in determining the voting slots.
 - f. The voters in whose name the mobile number is registered with a network operator shall be construed to have participated in the voting process.
 - g. BCCL shall have the right to use the names and other details of the votes (who have expressly granted such authorization to BCCL) on the platform.
 - h. Participant understands and agrees that merely participating in this voting process does not entitle the Participant to be selected for Jury meeting or to a prize or to any other form of consideration.
 - i. The decision of the Award Management regarding the voting process, selection of contestant / participants for jury meeting shall be final and binding.
